"BLÜCHER Class A Marine Drains Type 899-42047"

is a drain penetration system (outlet size Ø50 mm) composed of a removable water trap and a grating (Ø75 mm) on top. Steel pipe is fixed to the drain on the underside by means of a safety clamp with EPDM sealing. The drain penetration system is fully welded to the deck.
